WHO WE ARE

Pioneer Construction Inc. (“us,” “we,” or “our”) operates www.pioneerconstruction.ca (the “site”). This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site. By using the Site, you agree to the collection and use of information in accordance to this policy.

WHAT PERSONAL DATA WE COLLECT AND WHY WE COLLECT IT

Personal Data

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact you or identify you. Personally identifiable information may include but is not limited to your Personal information (Name, Phone Number, Email, Address, Postal Code, Driver License Number, etc.).

Log Data

Like many site operators, we collect information that your browser sends to us whenever you visit our Site (“Log Data”).

This Log Data may include information such as your computer’s Internet Protocol (“IP”) address, browser type, browser version, the pages of the Site that you visit, the time and date of your visit and the time spent on those pages along with other statistics.

FORMS AND METHODS OF COLLECTION

You personal information is collected through the following methods:

- Website Analytics
- Online/Physical Employment Application

COMMUNICATIONS

The main reason we collect personal information from you is:

- To complete employment applications
- Because it is required by law for complaints/inquiries
- To maintain/manage customer relationships
- In case of the need to respond to comments/concerns/complaints
- For marketing purposes

If it is a necessary part of these actions, we may disclose your information to a third party when legally required to.

COOKIES & FILE LOGS

We collect information through cookies. Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computers hard drive.

Like many sites, we use “cookies” to collect information. You can instruction your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies you may not be able to use some portions of our site.

In addition, we may use third party services such as Google Analytics that collect, monitor and analyze the data. This information allows us to process statistics and information regarding the website traffic to assist with easing navigation and improving experiences for our consumers.

Our website also embeds sharing and social media network buttons that allow you to share your activity across various platforms. Cookies and log files from the social media networks may be saved on your computer when you use these features.
